Borough Manager Sterner said the engineering firm that works with the one contractor. Does council want to do the nail stabilization method or the tear down and rebuild method?

Kim Mazur said the nail stabilization will cost less. He thinks if the borough does the tear down and rebuild the wall you will have to relocate the utilities in the road and that will get costly.

Borough Manager Sterner said Entech engineering will work with the company that does the nail launching. They will draw up the specs. It will be Entech Engineering project. They will work with them.

Kim Mazur said they will be working with Earth Environmental they do the technical specs and drawings. Entech would put the front end documents, bidding, prevailing wage, surveying, soil boring and work through the bidding process. The estimated cost is \$60,000.00

Borough Manager Sterner said that was included in the \$688,000.00 total. She asked council if they want to fix the wall.

All of council said yes.

Solicitor Nanovic asked if council would like to do this this year? Which method would you like to go with the soil nail launch or the tear down and rebuild it.
